School Responsibilities

The Wirt County Primary Center will:

1. Provide high-quality curriculum and instruction in a supportive and effective learning environment that enables the participating children to meet the State's student academic achievement standards as follows:

To meet the requirements for Support for Personalized Learning (SPL), Wirt County Primary Center follows the 3-tiered learning model. All students receive core instruction, strategic and intensive instruction is provided as needed, in reading and in math.

2. Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement. Those conferences will be held at least once a year.

3. Provide parents with frequent reports on their children's progress. Specifically, the school will provide reports as follows:

Wirt County Primary Center will send out midterm reports to the parents of those students who are struggling more than their peers. Regular report cards will be given out each nine weeks. The school will provide West Virginia year-end assessment results as they become available.

4. Provide parents reasonable access to staff. Specifically, staff will be available for consultation with parents as follows:

The staff will be available during their planning period. A conference room will be available for privacy.

5. Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows:

Wirt County Primary Center has a volunteer program which enables parents to come to school and be a participant. There are opportunities to tutor, assist the teacher in developing activities for the students, chaperone field trips and be an active member of the school's Parent Teacher

Organization.

Parent Responsibilities

We, as parents, will do our best to support our children's learning in the following ways:

- Monitoring attendance.
- Making sure that homework is completed.
- Monitoring amount of television my children watch.
- Volunteering in my child's classroom.
- Participating, as appropriate, in decisions relating to my children's education.
- Promoting positive use of my child's extracurricular time.
- Staying informed about my child's education and communicating with the school by promptly reading all notices from the school or the school district either received by my child or by mail and responding, as appropriate.
- Serving, to the extent possible, on policy advisory groups, such as being the Title I, Part A parent representative on the school's School Improvement Team, the Title I Policy Advisory Committee, the District wide Policy Advisory Council, the State's Committee of Practitioners, the School Support Team or other school advisory or policy groups.

OPTIONAL ADDITIONAL PROVISIONS

Student Responsibilities

We, as students, will share the responsibility to improve our academic achievement and achieve the State's high standards. Specifically, we will:

- Do my homework and ask for help when I need to.
- Read at least 30 minutes every day outside of school time.
- Give to my parents or the adult who is responsible for my welfare all notices and information received by me from my school every day.

Additional Required School Responsibilities

The Wirt County Primary Center will:

1. Involve parents in the planning, review, and improvement of the school's parental involvement policy, in an organized, ongoing, and timely way.
2. Involve parents in the joint development of any school wide program plan, in an organized, ongoing, and timely way.
3. Hold an annual meeting to inform parents of the school's participation in Title I, Part A

programs, and to explain the Title I, Part A requirements, and the right of parents to be involved in Title I, Part A programs. The school will convene the meeting at a convenient time to parents, and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite to this meeting all parents of children participating in Title I, Part A programs (participating students), and will encourage them to attend.

4. Provide information to parents of participating students in an understandable and uniform format, including alternative formats upon the request of parents with disabilities, and, to the extent practicable, in a language that parents can understand.
